On

Form and Minimum Information Requirements for Certificates of Origin

for Exported Goods under Non-Preferential Trade Schemes

HEREBY DECIDED

Article 1_ Objective

This Prakas (Ministerial Regulation) stipulates the form and minimum information requirements for certificates of origin under non-preferential trade schemes, known as "Form N," to ensure transparency, enhance trade facilitation, and contribute to the prevention of origin fraud.



Signature

Article 2_ Scope

This Prakas (Ministerial Regulation) shall apply to the export of goods manufactured or processed in the Kingdom of Cambodia under non-preferential trade schemes.

Article 3_ Form of Certificate of Origin

The certificate of origin form for exported goods under non-preferential trade schemes may be issued in either paper or electronic form, as set out in the Annex to this Prakas (Ministerial Regulation).

Article 4_ Minimum Information Requirements

The certificate of origin for exported goods under the non-preferential trade schemes shall contain, at a minimum, the following information:

- Name and address of the exporter;
- Name and address of the importer;
- Means of transport, place, and date of exportation;
- Country of origin;
- Country of destination;
- Mark and numbers;
- Description of goods and the harmonized system code at a minimum of four digits;
- Quantity of goods;
- FOB Value;
- Declaration of the exporter or producer;
- Date, signature, and official seal of the issuing authority of the certificate of origin;
- Supplementary details, if any.

Article 5_ Transitional Provisions

The certificate of origin for exported goods under non-preferential trade schemes which have been issued before the implementation of this Prakas (Ministerial Regulation) shall remain valid.

Article 6_

The Secretary-General of the General Secretariat, Director-General of the General Department of the Trade Support Services, Director-General of all General Departments, Director of the Export Import Department, Director of the Export Management in Special Economic Zones Department, Director of all Departments, and the Heads of Relevant Units shall be responsible for implementing this Prakas (Ministerial Regulation) in accordance with their respective duties as of the signature date.
